## Terms & Conditions

- 1.** I agree to comply with all applicable Laws, specifically Bangladesh Bank's direction and rules regarding International Roaming Service as regards to the use of Credit Cards.
- 2.** I have submitted Auto Bill Pay Authorization to Banglalink or Banglalink's duly authorized representative in person and the signature on this Form is penned by myself and which is not any form of copy or electronic signature.
- 3.** Auto Bill Pay Authorization will be in effect after 3 working days after Banglalink has received the duly filled form.
- 4.** I confirm that the mobile phone and the credit card mentioned in the Form belongs to me and that I am the authorized user of the mobile phone and the Credit Card. I have no objection regarding settling the bills (Local and/or Roaming) of me mobile phone, using the credit card whose details are provided in the Form.
- 5.** I acknowledge that Banglalink is the beneficiary of the payment deducted using the aforementioned Credit Card and shall settle the amount according to the option I have chosen overleaf. Banglalink may generate an interim bill at any time during the billing cycle or month and settle the bills according to the option I have chosen overleaf. The objective of generating and settling interim bills are – a) ensure the customer's outstanding dues do not cross his/her credit limit at any point of time, b) prevent any disruption in the service of the Mobile Phone.
- 6.** In the event of there not being a sufficient limit in my Credit Card to cover the respective amount in my bills, the transaction will be declined and I shall be liable to pay Banglalink the outstanding amounts.
- 7.** I acknowledge and undertake that Banglalink generated data is the sole authenticated document as to usage and billing records and I shall not refute any amounts stated in the bills with regard to settlement of amounts paid in this regard and I shall not defer or provide any instruction to stop or suspend payments from the Credit Card for any reason whatsoever. I also agree that I shall not raise any dispute regarding the aforementioned payments to Banglalink that are debited from the Credit Card.
- 8.** I agree that the Auto Bill Pay Authorization shall remain in full force and effect until otherwise advised in writing by myself. Any such amendments/cancellations will not release me from the liability to Banglalink arising on account of Banglalink executing the instruction before receipt of such amendments/cancellations. Auto Bill Pay Authorization will remain valid till the expiry date of the Credit Card and will be deemed as renewed upon the renewal of the Credit Card.
- 9.** I undertake, represent and warrant to comply with Banglalink's existing credit policy and any violation of that policy might result in temporary/permanent barring of mobile(s). I further undertake to unconditionally indemnify Banglalink and keep it harmless against any and all claims, costs, proceedings, demands, losses, damages, expenses or liabilities including all consequential loss which Banglalink may suffer/incure on account of my and/or my company's failure to comply in whole or in part of any of the terms and conditions of this letter including any violation of the usage of the Credit Card and non-compliance of any Bangladesh Bank regulations.
- 10.** Banglalink may revise and/or change any terms & conditions at any time. Such changes shall be effective from the date specified by Banglalink for such modifications and will be notified to me either in writing or publication thereof.
- 11.** The Form and the above terms and conditions are supplementary to the SAF (Subscriber Agreement Form).
